Midwest Barber college signed and returned to the Department the Certification and Agreement and the assurance that the institution used 100 percent of all HEERF II funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to our Students.

A total of \$7,743.00 was disbursed to 18 Students at the institution. 13 Students received grants of \$350.00, and 5 Students received grants of \$708.60. Students grant. For students to be determined eligible to receive grants under this program students must first be determined to be making satisfactory academic progress (SAP). The amount of aid was determined by determining the student's income and household size, and students who demonstrated a higher need received grants of \$708.60, all other eligible students received grants of \$350.00.
